1. Introduction

1.1 On the 16th July 2018, the Clinical and Care Governance Committee approved the recommendations contained within the Day Services Review (please see Appendix one) and remitted the Health and Social Care Senior Management Team with their implementation.

3. Background

- 3.1 Day Services refers to the range of support provided to groups of older people in settings where people attend for a period of the day or evening but do not stay overnight. Day Services are made up of two broad areas, Day Care and Day Centres. Day Care services provide personal care and are regulated by the Care Inspectorate. Day Centres are voluntary run organisations and do not provide personal care.
- 3.2 In 2017/18, Independent consultants were commissioned to undertake a review of all Day Services in Dumfries and Galloway. This report was finalised in June 2018. The Consultants produced a report setting out the findings, a high-level strategy and recommendations. This draft report was presented to the Clinical and Care Governance Committee for approval on16th July 2018.

4. Main Body of the Report

- 4.1 The Clinical and Care Governance Committee approved and agreed the Day Services Review, including the implementation of the recommendations outlined in the report, on 16 July 2018.
- 4.2 Clinical and Care Governance Committee members considered that the recommendations contained within the review report were operational and, as such, tasked the Health and Social Care Senior Management Team with responsibility for implementing these
- 4.3 To support this work to go forward, the Health and Social Care Senior Management Team consider that a direction from the IJB, reflecting the outcome as stated above, is needed.
- 4.4 A draft direction for the approval of the IJB is attached in Appendix 2.
