## **1. Introduction**

1.1 The Freedom of Information (Scotland) Act 2002 (FOISA) requires Scottish public authorities to adopt and maintain a publication scheme. Authorities are under a legal obligation to:

- i. Publish the classes of information that they make routinely available
- ii. Tell the public how to access the information they publish and whether information is available free of charge or on payment.

1.2 Dumfries and Galloway Integration Joint Board has formally adopted the Scottish Information Commissioner's Model Publication Scheme in November 2021.

## **2. Guide to Information**

2.1 The purpose of the Guide to Information is to:

- Allow anyone to see what information is available (and what is not available) in relation to each class
- State what charges (if any) may be applied
- Explain how you can find the information easily
- Provide contact details for enquiries and how to get help with accessing the information
- Explain how to request information we hold that has not been published

### **2.2 Availability and Formats**

The information we publish through the Model Publication Scheme is, wherever possible, available on the Dumfries and Galloway Health and Social Care Partnership website at [www.dghscp.co.uk](http://www.dghscp.co.uk)

We offer alternative arrangements for anyone who is unable to access the information online by providing a copy available in our Offices, at the address below, or we can arrange to send information to the requester by paper copy.

If you prefer to visit our Offices to view the information, you may be required to make an appointment to do so. Details on how to contact us are outlined in Section 2.7 below.

If you require information translated into another language, to **LARGE PRINT** or a different format please contact us and we will do our utmost to support this request.

### **2.3 Exempt Information**

We will publish all information we hold that falls within the classes of information as outlined below. If a document contains information which is exempt under the

Freedom of Information (Scotland) Act 2002 we may remove or redact the information before publication but the reason for this will be explained at the start of the document.

## **2.4 Copyright and re-use of Information**

The IJB holds the copyright for the vast majority of information in the Publication Scheme. All of this information can be copied or reproduced without our formal permission provided it is copied or reproduced accurately, is not used in a misleading context, is not used for profit and provided that the source of the material is identified.

Providing access to information does not mean that copyright has been waived, nor does it give the recipient the right to re-use information for commercial purposes. If you intend to re-use information obtained from the Publication Scheme, and you are unsure whether you have the right to do so, please make a request to:

## **2.5 Charges**

For paper copies of information we hold under this Scheme the IJB has agreed there will be no charge.

## **2.6 How to Access Information Not Available in the Model Publication Scheme**

If the information you are seeking is not available through the MPS then you may wish to request this from us.

If you submit a request to us for information which is not available through this Publication Scheme but is available under the FOISA, charges will be based on the following calculations:

- There will be no charge for information requests which cost us £100 or less to process
- Where information costs between £100 and £600 to provide you may be asked to pay 10% of the cost.
- For requests that would cost more than £600 we will ask you to pay the full cost

- In calculating fees, staff time will be calculated at actual cost per staff member hourly salary rate to a maximum of £15 per person per hour
- Charges will only be made for locating, retrieving and providing information to you.
