1.	<p><b>Introduction</b></p> <p>1.1 This Report and the Register of Interests for Members of Dumfries and Galloway Integration Joint Board, attached at <b>Appendix 1</b>, is procedural and is brought before the Integration Joint Board as it is required under legislation to be available for public inspection.</p>

3.	<p><b>Background and Main Report</b></p> <p>3.1 The Ethical Standards in Public Life etc. (Scotland) Act 2000 Section 7 Register of Interests outlines that all public bodies shall set up, maintain and make available for inspection a Register of Interests of its Members.</p> <p>3.2 Each Member must provide information to the Standards/Governance Officer of the IJB on Gifts and Hospitality, Remuneration, Related Undertakings, Contracts, Houses, Land and Buildings, Shares and Securities and Non Financial Interests, which may impact on their role as a member of the Integration Joint Board.</p> <p>3.3 In September 2021, the Governance Officer wrote to all IJB Members to ask them to review their information held on the register and update the information as required.</p> <p>3.4 This process must be reviewed annually, however the onus is on individual IJB members to inform the Governance Officer of any changes regarding the information held on the Register within one month of the change occurring.</p> <p>3.5 The Governance Officer must make available the Register of Members Interest for public inspection at the office of the Integration Joint Board at all reasonable hours. The Register will also be made available via <a href="http://www.dghscp.co.uk">www.dghscp.co.uk</a> website.</p>
4.	<p><b>Conclusions</b></p> <p>4.1 Based on the information provided the Integration Joint Board is asked to note the Register of Members Interest.</p>

In accordance with the Ethical Standards in Public Life (Scotland) Act 2000 (Register of Interests) Regulations 2003 Number 135 as amended, Board Members of devolved public bodies are required to give notice of their interests under the following headings:-

#### **Category One: Remuneration**

- i. You have a Registerable Interest where you receive remuneration by virtue of being:

- employed;
  - self-employed;
  - the holder of an office;
  - a director of an undertaking;
  - a partner in a firm; or
  - undertaking a trade, profession or vocation or any other work.
- ii. In relation to the above, the amount of remuneration does not require to be registered and remuneration received as a member does not have to be registered.
  - iii. If a position is not remunerated it does not need to be registered under this category. However, unremunerated directorships may need to be registered under category two, "Related Undertakings".
  - iv. If you receive any allowances in relation to membership of any organisation, the fact that you receive such an allowance must be registered.
  - v. When registering employment, you must give the name of the employer, the nature of its business, and the nature of the post held in the organisation.
  - vi. When registering self-employment, you must provide the name and give details of the nature of the business. When registering an interest in a partnership, you must give the name of the partnership and the nature of its business.
  - vii. Where you undertake a trade, profession or vocation, or any other work, the detail to be given is the nature of the work and its regularity. For example, if you write for a newspaper, you must give the name of the publication, and the frequency of articles for which you are paid.
  - viii. When registering a directorship, it is necessary to provide the registered name of the undertaking in which the directorship is held and the nature of its business.
  - ix. Registration of a pension is not required as this falls outside the scope of the category.

### **Category Two: Related Undertakings**

- i. You must register any directorships held which are themselves not remunerated but where the company (or any other undertaking) in question is a subsidiary of, or a parent of a company (or other undertaking) in which you hold a remunerated directorship
- ii. You must register the name of the subsidiary or parent company or other undertaking and the nature of its business, and its relationship to the company or other undertaking in which you are director and from which you receive remuneration
- iii. The situations to which the above paragraphs apply are as follows:
  - You are a director of a board of an undertaking and receive remuneration declared under Category one; and

- You are a director of a parent or subsidiary undertaking but do not receive remuneration in that capacity.

### **Category Three: Contracts**

- i. You have a registerable interest where you, or a firm in which you are a partner, or an undertaking in which you are a director or in which you have shares of a value as described in Category 6 (i), have made a contract with NHS Dumfries and Galloway or Dumfries and Galloway Council:-
  - a. under which goods or services are to be provided; or works are to be executed; and
  - b. which have not been fully discharged
- ii. You must register a description of the contract, including its duration, but excluding the consideration.

### **Category Four: Houses, Land and Buildings**

- i. You have a registerable interest where you own or have any other right or interest in houses, land and buildings, which may be significant to, of relevance to, or bear upon, the work and operation of the body to which you are appointed.
- ii. The test to be applied when considering appropriateness of registration is to ask whether a member of the public acting reasonably might consider any interests in houses, land and buildings could potentially affect your responsibilities to the organisation to which you are appointed and to the public, or could influence your actions, speeches or decision making.

### **Category Five: Interest in Shares and Securities**

- i. You have a registerable interest where you have an interest in shares comprised in the share capital of a company or other body which may be significant to, of relevance to, or bear upon, the work and operation of (a) the body to which you are appointed and (b) the **nominal value** of the shares is:
  - a. greater than 1% of the issued share capital of the company or other body; or
  - b. greater than £25,000.
- ii. Where you are required to register the interest, you should provide the registered name of the company in which you hold shares; the amount or value of the shares does not have to be registered.

### **Category Six: Gifts and Hospitality**

- i. You must register the details of any gifts or hospitality received within your current term of office, except that it is not necessary to record any gifts or hospitality as described as follows:
  - a. isolated gifts of a trivial character the value of which must not exceed £50;
  - b. normal hospitality associated with your duties and which would reasonable be regarded as appropriate; or
  - c. civic gifts received on behalf of the public body

**Category Seven: Non Financial Interests**

- i. You may also have a registerable interest if you have non-financial interests which may be significant to, of relevance to, or bear upon, the work and operation of the IJB to which you are appointed. It is important that relevant interests such as membership or holding office in other public bodies, clubs, societies and organisations such as trades unions and voluntary organisations, are registered and described. This requirement also applies where, by virtue of your membership of a particular group, you have been appointed to the IJB.
- ii. In the context of non-financial interests, the test to be applied when considering appropriateness of registration is to ask whether a member of the public might reasonably think that any non-financial interest could potentially affect your responsibilities to the organisation to which you are appointed and to the public, or could influence your actions, speeches or decision-making.
