1.1 This Report provides the Committee with an update on progress made on Directions issued to date to NHS Dumfries and Galloway and Dumfries and Galloway Council.

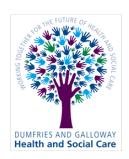
2. Recommendations

 - Discuss and Note progress made against the Directions issued to date

3. Background and Main Report

- 3.1 The Public Bodies (Joint Working) (Scotland) Act 2014 (Section 26) highlights that the Integration Joint Board must give a direction to a constituent authority to carry out each function delegated to the integration authority to which they must comply.
- 3.2 Functions which are delegated to the IJB are outlined in the Integration Scheme between NHS Dumfries and Galloway and Dumfries and Galloway Council.
- 3.3 From the report attached at **Appendix 1**, Members will see that 16 Directions have been issued to date and are summarised as follows:
 - Following a review in 2019 2 Directions were deemed no longer relevant Regional Planning and Options Appraisal for Vascular Surgery, both of these were taken forward by the NHS Board.
 - There are two Directions which have now been superceded
 - the Scoping of Dumfries and Galloway Learning Disability Services now superceded by the Development of a Dumfries and Galloway Learning Disability Strategy which is due to be completed in 2020 and will be presented to the IJB thereafter
 - Day Services Review now superceded by Day Services direction which will next be reported in December 2020
 - Three Directions are now completed
 - Implement the Carers (Scotland) Act 2016
 - Develop and implement a Service Planning Framework for the IJB
 - Development of a Strategic Advocacy Plan for Adults
 - Of the remaining 9 Directions an update is as follows
 - Provide Delegated Services to Dumfries and Galloway Integration Joint Board – this will continue to be the overarching Direction
 - Dumfries and Galloway Strategy for Mental Health 2017-2027, a Programme Board has been set up and this continues to be reported via Health and Social Care Senior Management Team (HSCSMT) and is in line with national work
 - Review of Health and Social Care Services in Wigtown This is due for completion by April 2020 and will be reported to HSCSMT and the IJB thereafter
 - Development of a Local Digital Strategy and Delivery Plan the Plan is currently out for consultation and will be presented to HSCSMT in March and the IJB in April

Development of a Dumfries and Galloway Learning Disability Strategy, this is due to be completed by September 2020 and will be reported to HSCSMT and the IJB in October 2020 Provision of GP Services in Moffat – this is overdue for reporting o Development of a Consultation Framework - this has been completed and is due to be reviewed at HSCSMT in January and the IJB in February 2020. It was agreed at the HSCSMT that is not the subject of a delegated function, a Direction should not have been issued. o Re-commissioning of Carers Support Services to support the implementation of the Dumfries and Galloway Carers Strategy 2017-2021, this is due to be reviewed in March 2020 Day Services – this is due to be reviewed in December 2020 4. Conclusions 4.1 Based on the information provided, Members are asked to discuss and note the update on Directions issued to date. **Resource Implications** 5. 5.1 Directions which are issued must have clear resource implications outlined within the content of the Direction.
