Summary of current IJB Directions, linked Annual Delivery Plan actions by Strategic Commissioning Intention

The Health and Social Care Directorate in collaboration with the Strategic Planning and Transformation Directorate have undertaken a mapping exercise to demonstrate the progress of Directions by mapping Directions to the Partnership's Annual Delivery Plan which is submitted on a quarterly basis to Scottish Government.

This paper outlines each Direction with associated delivery actions with the aim of providing assurance that the received Directions are being progressed. This process has highlighted areas of improvement in terms of the governance structure therefore a refresh of the current procedure is under review and we shall undertake audits against our governance processes to ensure adherence to process.

We do still have some areas that require clarification which is outlined as a suggested Direction to be issued however; the team are in the process of reviewing such suggested Directions and associated actions.

There are currently 30 open directions where we have applied a RAG Status in terms of progress; additionally we have made suggestions where Directions need closed due to being either historical or completed.
