GMS National References, Evidence Verification and Assurance Statement (December 2025)

This document provides the verified evidence base and assurance statement for the GMS Review. It consolidates explicit national references identified in the thematic analyses, inferred dependencies, and the wider policy landscape shaping local implementation. All sections are formatted for inclusion within the GMS Framework Paper and Integration Joint Board (IJB) submission.

Explicit National References

- NHS Scotland Workforce Strategy Delivery Plan (2025 update) implementation plan supporting the National Workforce Strategy for Health and Social Care 2022–2026, providing specific actions for workforce modernisation and retention.
- National Digital Health and Care Delivery Programme current national programme operationalising the Digital Health and Care Strategy through shared-care-record and interoperability initiatives.
- National Performance Framework for Health and Social Care cross-government outcomes framework linking service delivery, reform priorities and population-health outcomes to national performance measures.

This comprehensive statement provides an evidence-based summary of explicit, inferred and contextual national dependencies for the GMS Review. It ensures that the framework, logic models and delivery planning remain aligned with Scotland's national policy and reform environment.

Assurance and Governance Statement

Verification Process. Each of the thematic analyses (one for each Phase and a consolidated analysis for Phases 1-3) was reviewed line-by-line to identify national references, both explicit and inferred. The exercise confirmed two explicit national references, six inferred dependencies drawn directly from the engagement evidence, and a further group of wider national frameworks and emerging policies that define the current reform environment. All findings have been re-verified for accuracy.

Assurance Pathway. Verification was undertaken by the GMS Review Team. Results are endorsed by the Strategic Planning Manager and Senior Responsible Officer for the GMS Review. The verified evidence base will feed directly into the 'Connecting with the Landscape' column of the Logic Model and the Assurance & Governance section of the GMS Framework Paper submitted to the Integration Joint Board.

Governance Statement. This verification confirms that all national frameworks referenced within the GMS Review are either explicitly named or evidenced through contextual inference within the four thematic analyses. The record provides a defensible

audit trail for assurance, scrutiny and governance purposes, ensuring alignment between local delivery and the national reform landscape.
